

NATIONAL MUSEUM BIDS AND AWARDS COMMITTEE Sub-Committee on General Services

RESOLUTION NO. 2015-GSR-005

WHEREAS, the National Museum intends to procure and engage the services of a consultant to conduct the **Detailed Engineering Studies (DES) of Heritage Structures Declared as NCT/ICP in Bohol and Samar affected by calamities**, with an Approved Budget for the Contract (ABC) in the amount of *Twenty Five Million Three Hundred Fifty Six Thousand Two Hundred Forty Pesos (PhP 25,356,240.00)*;

WHEREAS, during the conduct of public bidding for the purpose, four failure of biddings were declared, thus, the NMBAC recommended to the Director IV the resort to a negotiated procurement under Section 53.1 (Negotiated Procurement-Two Failed Biddings) of the Revised IRR of R.A. No. 9184, which was duly approved by the latter;

WHEREAS, the Request for Expression of Interest for the rebidding the Detailed Engineering Studies (DES) of Heritage Structures Declared as NCT/ICP in Bohol and Samar affected by calamities, was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, NM website, designated bulletin board of the National Museum and published in the Philippine Star, from December 18-26, 2014 in accordance with the schedule agreed upon during the preprocurement conference held on December 15, 2014 at the Office of the Acting Director III;

WHEREAS, five (5) observers namely: Mrs. Maritess M. Pineda (President, Museum Foundation of the Philippines, Inc.), Mr. David Sanchez (National President, Philippine Institute of Civil Engineer) and Ms. Victoria Yumang (State Auditor IV, Commission on Audit), Mr. Isagani Serrano (President, Philippine Rural Construction Movement), and Mr. Mauro Alvarez (Representative, National Museum Rank and File Association) were invited to witness/sit in the NMBAC proceedings in relation to the procurement process of aforementioned project (original receiving copies of the Letters Invitation attached and marked as Annexes "A" to "A-4");

WHEREAS, in response to the advertisement of the Request for Expression of Interest, only one (1) prospective bidder/consultant, Digiscript Philippines, Inc., in joint venture with Philippine Geoanalytics, Inc., submitted its letter of intent, as the consultant has previously submitted its eligibility requirements, undergone eligibility check, and was declared as eligible (original copy of NMBAC Resolution No. 2014-GSR-2014-044, NMBAC Resolution No. 2014-GSR-047 and original receiving copy of the Certification dated December 23, 2014 are hereto attached and marked as Annexes "B" to "B-2"), the consultant was shortlisted based on the Criteria for shortlisting of consultants (NMBAC Resolution No. 2014-GSR-043, an original copy of which is hereto attached as Annex "C");

WHEREAS, the CONSULTANT submitted its Technical and Financial Documentary Requirements through its representative/s, who were present during the opening of the Technical Requirements envelop on January 20, 2015, 10:00 a.m. at the NMBAC Room, 3rd Flr., National Art Gallery Bldg.;

WHEREAS, the NMBAC and end-user, with the assistance of the Technical Working Group (TWG) and the Secretariat, evaluated the Technical Documents of Digiscript Philippines, Inc., in joint venture with Philippine Geoanalytics, Inc., using both the non-discretionary "pass/fail" criteria and the Quality-Cost Based Evaluation Procedure (QCBE) criteria embodied in NMBAC Resolution No. 2014-GSR-049, excluding however, the formula for ranking since there is only a Single Rated Bid (SRB), and determined that Digiscript Philippines, Inc., in joint venture with Philippine Geoanalytics, Inc., has passed both evaluation for the Technical Requirements. An official letter stating such fact and inviting the CONSULTANT to participate in the opening of its Financial Documents on January 21, 2015, 1:30 p.m. at NMBAC Room, 3rd Floor, National Art Gallery Bldg. (Annex "D");

WHEREAS, the NMBAC and end-user has determined that Digiscript Philippines, Inc., in joint venture with Philippine Geoanalytics, Inc., passed the evaluation for the Financial Requirements. On account thereof, the End-user, with the assistance of the NMBAC, engaged in a formal negotiation with Digiscript Philippines, Inc., in joint venture with Philippine Geoanalytics, Inc., involving other terms, conditions and technicalities of the project, the approval of which is contained in NMBAC Resolution No. 2014-GSR-004 (original copy of the letter of negotiation from the National Museum to the consultant and original copy of the letter response of the CONSULTANT are hereto attached as Annexes "E" and "F");

WHEREAS, upon post-qualification and careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Digiscript Philippines, Inc. in joint venture with Philippine Geoanalytics, Inc., the same was found to have been responsive to all the requirements, under the Terms of Reference and the other relevant Bidding Documents (an original copy of the duly accomplished post-qualification report is hereto attached and marked as Annex "G");

NOW, THEREFORE, we, the members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- To declare Digiscript Philippines, Inc. in joint venture with Philippine Geoanalytics, Inc., as the Bidder with Single Rated and Responsive Bid for the Consulting Services in relation to the Detailed Engineering Studies (DES) of Heritage Structures Declared as NCT/ICP in Bohol and Samar affected by calamities;
- To recommend award of the abovementioned contract to Digiscript Philippines, Inc. in joint venture with Philippine Geoanalytics, Inc., with office address at 4F BT & T Center 20 E. Rodriguez Jr. Ave., Libis, Quezon City in the amount of Twenty Four Million Nine Hundred Thousand Five Hundred Fifteen Pesos and Ninety Two Centavos (Php24,900,515.92); and
- To recommend for approval by the Director IV of the National Museum the foregoing findings.
